



Purpose of a Regional Plan

- Who: DHHL updates the plan in partnership with the homestead community and other stakeholders
- What: Implements the Island Plan by focusing on a specific region
- Where: DHHL lands in Pana'ewa and Waiākea (see map)
- When: 8-year time horizon
- Why:
 - Previous plan prepared in 2009 (8 years ago); timely to update
 - Reevaluate priorities
 - Build partnerships to strengthen implementation

Project	Status
Restore Pana'ewa Family Center	Completed July 2012
Establish working group to improve farming	Project has 12 components; completed 2 of 12 components
Develop Kamoleo	In progress
Generate income for Pana'ewa	Started
Improve road infrastructure	Partial (traffic calming and stop signs)
