**ITEM NO. 2 QUESTIONS AND CLARIFICATIONS RECEIVED AS OF 5/23/16**

**1. Can BioSock be used as an equal to Dandy products**

Answer: Yes BioSock can be used and is considered equal

**2. On Sheet C-3, there is a call out for RWE034. Can you please clarify this? There are call outs for RWE03A on the plans sheet, but there are details for G Flare, Fleat-350, and A Flares (Sheets C-7 to C-12). Are these to be used on the project?**

Answer: There was a misunderstanding on the amount of details that were required by the State DOT. For this project only one style of end treatment is to be used. The detail is titled "W-BEAM END SECTION (ROUNDED RWE03A)" and is located on DWG. No. C-6, bottom, middle detail. Please note on DWG. NO. C-3 at Sta 493+65.45, the end treatment shall be corrected from "RWE034" to "RWE03A"

**3. On Sheet TC-1, it calls out for Construction Work Zone signs:  
Are these to be placed on Maluokalani Street and/or Honokoa Street?**

Answer: No these are not required on Maluokalani Street and / or Honokoa Street, only on Akoni Pule Highway.

**4. Are Advisory Boards going to be required per section 645.03 (G)?**

Answer: No advisory board is required.

**5. Finally is an Advertisement required?**

Answer: No advertisement is required by contractor, but contractor shall provide DHHL required information if DHHL needs to advertise.

2. Purpose of Pre-Bid Conference:

- a) To provide potential bidders with a project overview and job site visit.
- b) To review procurement requirements and allow potential bidders to ask questions and obtain clarification on the bid documents. A written summary of this pre-bid conference will be issued to all plan holders as an Addendum.

3. Scope of Work:

- a) This project consists of furnishing all labor, equipment and supervision to satisfactorily complete the DHHL Kawaihae Guardrail Installation project in Kawaihae, South Kohala, Island of Hawaii.
- b) The project scope of work includes installing approximately 940 linear feet of guardrail along two sections of Akoni Pule Highway in Kawaihae. Work also includes the removal and delivery of existing guardrail and posts to the State DOT Baseyard, installation of required terminal end sections, and both traffic and erosion control during the construction period.

4. General Requirements:

- a) This project is not tax exempt. Your bid proposal must be inclusive of General Excise Tax.
- b) This project is subject to Chapter 104 HRS, State Department of Labor and Industrial Relations (DLIR) prevailing wages and salaries. Wage Rate Schedule Bulletin No. 487, effective February 15, 2016 is included in the bid documents.
- c) After bid opening and prior to award of the contract, the Department shall verify compliance with Sections 103D-310 and 103D-328 HRS via Hawaii Compliance Express (HCE) for the bidder and all subcontractors. Instructions for registration are at the HCE website: <http://vendors.ehawaii.gov>.
- d) Failure by the bidder and/or any subcontractor to rectify a non-compliant status within ten business days of notification will be considered as sufficient for the disqualification of the bidder and rejection of its proposal.

5. Completion Schedule and Liquidated Damages:

- a) Time to complete: Hundred Eighty (180) calendar days from written Notice to Proceed
- b) Liquidated damages: Five Hundred dollars (\$500) per calendar day
