HAWAII ADMINISTRATIVE RULES TITLE 10 CHAPTER 6.1 states that the purpose of the Native Hawaiian development program is to improve the general welfare and condition of native Hawaiians through educational, economic, political, social, cultural and other programs. The native Hawaiian development program shall have a hierarchical structure of goals, objectives, and action plans. The primary goal of the native Hawaiian development program shall be to increase the self-sufficiency and self-determination of native Hawaiian individuals and native Hawaiian communities. The native Hawaiian development program plan (NHDP) shall specify the goals, objectives, action plans, and implementing mechanisms applicable during the fiscal biennium covered by the plan. The Hawaiian Homes Commission adopted the 2009-2011 Plan in 2009 and we invite you to participate in the development of the new 2011-2013 plan.
