REPORT REQUIREMENT OF ACT 134, SLH 2013, GENERAL APPROPRIATIONS ACT OF 2013

"SECTION 17. Provided that of the non-recurring, general fund appropriation for planning and development for Hawaiian homesteads (HHL 602), the sum of \$9,632,000 for fiscal year 2013-2014 shall be expended only to carry out the functions and duties of the department as specified by and pursuant to the State Constitution; provided further that these funds be expended only for administrative and operating expenses of the department of Hawaiian home lands; provided further that any unexpended funds shall lapse to the general fund at the end of the fiscal year for which it was appropriated; provided that the department of Hawaiian home lands shall prepare a detailed report on the expenditure and use of funds from the general fund appropriation of \$9,632,000 for operating expenses for fiscal year 2013-2014 and fiscal year 2014-2015; and provided further that the department of Hawaiian home lands shall submit the report to the legislature no later than thirty days prior to the convening of the 2014 and 2015 regular sessions.
