## MINIMUM QUALIFICATION REQUIREMENTS:

### Education:

Baccalaureate degree from a four (4) year accredited university in planning, environmental sciences or a related field.

### Specialized Experience:

Three and one-half (3-1/2) years of progressively responsible professional planning or resource management experience which included the collection and evaluation of an extensive variety of physical, social, economic, and environmental data; determination of public opinion and general community objectives and policies to obtain a comprehensive perspective of conditions and identify problems and opportunities in the area(s) of concern.

Experience must have entailed actual involvement in and responsibility for the integration of such information (consideration of relationships among resources, facilities, services, needs, and values for the development of policy options, alternatives for actions, programs and priorities to meet goals and objectives for a given geographic area of concern).

Experience in advising and assisting others on planning concepts and methods, providing technical information and analysis for the formation of plans and programming of plans; and formulation and presentation of plans and policy recommendations to decision makers.

Experience in producing geographic information and maps from computer geographic information systems is desired.

Experience in conducting planning work in native Hawaiian communities or groups is desired.

### Substitutions:

- 1) Progressively responsible Experience in administrative, professional, technical, analytical or other responsible work which required the knowledge of and ability to perform research (which included statistics), organize work effectively, solve problems, write reports, speak effectively and deal effectively with people, may be substituted for Education on a year-for-year basis.
- 2) A master's degree from an accredited university in environmental sciences, planning or a related field may be substituted for a minimum of one and one-half (1-1/2) years of the Specialized Experience requirement if in a comparable field of study;
- 3) A Ph.D. from an accredited university in environmental sciences or a related field will fulfill all requirements.
