### **HHL EQUIPMENT OPERATOR III**

Temporary, Exempt Non-Civil Service Appointment

This position is located on the Island of Hawaii, Waimea

#### **DUTIES SUMMARY**

This position operates two or more types of motorized equipment such as heavy trucks, heavy rollers, lawn mowers, loaders, excavators, and bulldozer as a major work assignment and performs manual work tasks in connection with maintaining roads and road repairs, trim grass, shrubs, and trees, performs general and preventative maintenance to equipment, and other duties as assigned and required.

#### **MINIMUM QUALIFICATION REQUIREMENTS**

##### General Experience:

One (1) year of work experience involving the operation of at least two of the motorized equipment representative of the class Equipment Operator III (e.g. heavy motorized such as trucks having a factory rated capacity of 5 tons or over, rollers of 5 tons or over, loaders, and tractors such as D-4, TD-6 and TD-9 with bulldozer blade attachments), or any equivalent combination of training and experience.

##### Quality of Experience:

Possession of the required number of years of experience will not in itself be accepted as proof of qualification for a position. The applicant's overall experience must have been of such scope and level of responsibility as to conclusively demonstrate that he/she has the ability to perform the duties of the position for which he/she is being considered.

##### License Required:

Valid State of Hawaii Driver's License and a valid Commercial Driver's License of the appropriate type, as applicable.

Legal Authorization to Work Requirement: The State of Hawaii requires all persons seeking employment with the government of the State shall be citizens, nationals, or permanent resident aliens of the United States, or eligible under federal law for unrestricted employment in the United States.

#### **OTHER INFORMATION**

This position is exempt from the civil service and considered temporary in nature. Therefore, if you are appointed to the position, your employment will be considered to be "at will," which means that you may be discharged from your employment at the prerogative of your department head or designee at any time.

Recruitment is continuous until needs are met.
