SUBJECT: REPORT OF SANITARY SURVEY  
PUBLIC WATER SYSTEM NO. 164, KAWAIHAE UNIT #1

Thank you for the assistance and information provided during the sanitary survey inspection of the Kawaihae Unit #1 water system conducted on October 24, 2017.

My staff appreciated the assistance provided by yourself and Messrs. Harold Hart and Travis Gomes.

A sanitary survey of a public water system is a periodic review of the system's facilities, operation and maintenance practices, and records to assure that proper conditions, policies, and practices are in effect for that water system. Maintaining of minimum standards of operation and maintenance is the responsibility of the operator.

As of December 1, 2009, systems must comply with the sanitary survey requirements of the Ground Water Rule (GWR). The Rule requires ground water systems with an identified "**significant deficiency**" to consult with the State on a corrective action plan and schedule of completion within 30 days of receiving written notice of the deficiency. The system must complete the corrective actions or be in compliance with the agreed upon corrective action plan and completion schedule within 120 days of receiving written notice of the deficiency. All significant deficiencies identified during the sanitary survey were promptly corrected by Pural Water Specialty Co., Inc.
