

This letter serves as confirmation that you have met the minimum requirements to proceed to a vacant lot selection as the next step in the awards process.

The Department received more than 23 undivided interest lessees and applicants who met the minimum requirements for this offer, so we want to inform you that all 23 lots may be selected before we are able to call your name.

Lot Selection Process:

At the lot selection meeting, you will have the opportunity to select your desired lot from the 23 available lots in the Ka'uluokaha'i Subdivision Increment B. The Department will call the eligible Undivided Interest Lessees then Applicants by name in order of their original application date. If you are not present to select a lot when called, you may be deferred from this lot selection.

You must attend the lot selection, however, if you are not able to attend the meeting, you may authorize someone to act as your proxy with a notarized "Lot Selection Authorization" form. The proxy form is included with this letter and will need to be completed **and** notarized prior to lot selection. This form **must be presented** at the time of lot selection along with a valid government ID of the person selecting the lot. If the proxy form is not completed or notarized, your authorized person **will not** be able to select a lot on your behalf.

Important Information:

- 1) Bring this letter and other materials you received for your reference.
- 2) Bring a valid government ID

3) ***If you cannot attend the meeting and someone will be attending for you, have your designated person (Proxy) bring the signed and notarized proxy form to the meeting with a valid government ID. If the proxy form is not notarized, your designated attendee will not be allowed to select a lot.***

- ***DO NOT MAIL OR DROP OFF THE PROXY FORM TO DHHL***

Again, congratulations on your journey towards homeownership for your ‘Ohana! The Department of Hawaiian Home Lands is dedicated to fulfilling Prince Kuhio’s mission through the Hawaiian Homes Commission Act 1920 to return native Hawaiians to their lands.
