The Pre-bid Conference was held at the Department of Hawaiian Home Lands (DHHL) West Hawaii District Office at 64-754 Mamalahoa Highway. Meeting commenced at 9:03 AM. (See Attachment 1, sign in sheet for members in attendance.)

Sara Okuda (DHHL) read through the Pre-bid Conference Agenda (See Attachment 2 for Pre-bid Conference Agenda.) Agenda included Introductions, Purpose, Scope of Work, Procurement reminders, Completion Schedule and Liquidated Damages, and Deadlines.

Questions/Answers:

- What triggers Liquidated Damages?
 - For this Operation and Maintenance contract, work is required weekly, monthly, and yearly. Should the Contract not perform this work as required, Liquidated damages can be assessed per day of periods determined to be not in compliance.
- Can water usage through DWS and customer use records be obtained?
 - At present time, DHHL is not monitoring consumption.
- How many backflow assemblies are existing?
 - There are currently 46 customers/backflow assemblies to maintain.
- Can Contractor provide a generator that will alternate with existing generator installed permanently onsite in an enclosure instead of purchasing a trailer-mounter spare diesel pump (Bid Item No. 2)?
 - Item No. 2 is a set Bid Price Contingent Item and will not vary between bidders. The Contractor awarded this contract may propose alternate to Bid Item No. 2 to be approved by DHHL, as DHHL deems necessary.
- What is the kW of the existing generator at Tank #2?
 - 36.3 kW
- Are the existing backflow Preventers installed in concrete?
 - Construction plan detail shows concrete thrust blocks at reducer/elbow.

Perform complete operation, maintenance, reporting, and repair services of the Puukapu Non-Potable Water System, including all pumps, water tanks, distribution water lines, water meters and valves, backflow prevention assemblies, telemetering and electrical systems, solar panel system, equipment security fencing, and appurtenances. Also install or store new water meters and backflow prevention assemblies, perform emergency call-outs, maintain vegetative growth at facilities, and address other water system needs.

4. **Procurement reminders**

- This project is not tax exempt. Your bid proposal must be inclusive of General Excise Tax.

- This project is subject to 103.55 HRS, Wages, Hours, and Working Conditions of Employees of Contractors Performing Services.
 - After offer is due and prior to award of the contract, the Department shall verify compliance with Sections 103D-310 and 103D-328 HRS via Hawaii Compliance Express (HCE) for the bidder and all subcontractors. Therefore, the bidder and all subcontractors are encouraged to register with HCE. Instructions for registration are at the HCE website: <http://vendors.ehawaii.gov>.
 - Failure by the bidder and/or any subcontractor to rectify a non-compliant status on HCE within ten business days of notification will be considered as sufficient for the disqualification of the bidder and rejection of its proposal.
5. **Completion Schedule and Liquidated Damages**
- Time of Performance: Three (3) Consecutive Years after the Notice to Proceed is issued.
 - Liquidated damages: \$250.00 per day.
