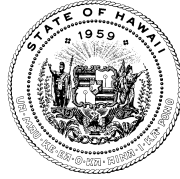

Indication of Interest

The Department of Hawaiian Home Lands (DHHL) previously notified the East Kapolei IIB & C Undivided Interest Lessees and Oahu Islandwide Residential Wait List with application dates up to December 31, 1985 of an offering of twenty-three (23) vacant lots in the Ka'uluokaha'i Subdivision Increment IIB. Upon completion of Offer #1, **five (5) vacant lots** remain available for selection. Therefore, we are continuing this offer by contacting applicants with current addresses on the Oahu Islandwide Residential Wait List with application dates from January 1, 1986 – December 31, 1990.

The Department recognizes that beneficiaries are seeking other options that may be more conducive to their financial capabilities and the needs of their families. This option may provide those families with the flexibility to build the home of their choice and in their price range. Construction on these lots can be either for owner-contractor built homes or homes built by Habitat for Humanity, which is a self-help program



Those that are not able to select a lot will be placed on a backup list in their rank order. **Those on the backup list will only be contacted if any of these lots becomes available.** The backup list will be terminated once the lease awards for the available lots are recorded.
