Initially, the family relocated from Mau`i to Honolulu several years ago due to Mr. Koko's medical condition. Since then, he has aged to a point where homecare is vital, and financial challenges have warranted the family to seek homecare from family members on Mau`i who can accommodate his needs. Recommendation is to assist the family in their relocation efforts due to a medical necessity.

It has been the Commission's policy to permit those lessees who are on the land, to be granted relocation for specific reasons, noted Deputy Chairman Bob Hall. In this case, should the commission grant a medical request, the family will be considered as a priority to relocate on Mau'i. One of the conditions noted is the family will be required to qualify for a homestead.

DISCUSSION

Puni Kekauoha, Executive Director, Papakolea Community Development Corporation (PCDC) submitted a report to be made a part of these minutes as Exhibit "A". The report is part of a directive from the Hawaiian Homes Commission (HHC) at its monthly meeting of November 16, 2010 to have PCDC and Papakolea Community Association (PCA) engage in discussions on utilizing a community economic development (CED) grant of \$250,000 which was awarded to PCDC. Homesteaders through community meetings were to be informed of its economic goals, direction and projected outcome. PCDC and PCA engaged in its first joint meeting on November 15, 2010; however, further attempts to schedule follow-up meetings with PCA board members have failed.

Over 500 homesteaders and community partners have been contacted through community meetings, newsletters and flyers. A briefing was provided to a City and County Council member and Hawai'i State Senators as well as staff members of Senators Akaka and Inouve.

Senator Carol Fukunaga and Congressional Senator Dan Inouye acknowledged interest in a kupuna project as well as improvements to the Punchbowl Cemetery site. Two cultural sites in Punchbowl Cemetery have been recognized by the federal government as historical sites. The goal is to work in partnership with the Veteran Affairs and National Cemetery Association which PCDC has provided a letter of support.

Commissioner M. Kamaka and Chairman Nahale-a thanked Puni Kekauoha for her report and her continual dedication and commitment expressed to the beneficiaries of Papakolea.

Land Development Administrator Sandy Pfund presented an informational update on the DHHL Ka Pua Makaha project in Makaha which is in partnership with Kamehameha Schools to provide a Hawaiian homes community of 236 acres surrounding a 67 acre parcel for Kamehameha Schools Learning Center. To continue with this project, effort needs to be maintained to move this project forward, noted Ms. Pfund.

Public and community outreach has been sustained in the Waianae, Nanakuli, Makakilo-Kapolei neighborhood boards ever since its inception in January, 2010. A memorandum of Agreement (MOA) was approved in March, 2010 between DHHL and Ko`olina Makaha developer to convey certain lands. The department is working towards due diligence by having most obligations completed by next month. PBR has been hired as a consultant to develop studies such as soil testing and environmental assessment on the project. There may be an extension request to delay due diligence until August, 2011. Because the area was formerly sugar cane lands prior to being turned into a golf course, specific areas are being targeted for soil testing of pesticides.

Chairman Nahale-a thanked Ms. Pfund for pursuing this project which has a lot of potential for our beneficiaries.

Papakolea Community Development Corporation (PCDC) respectfully submits a report to you and members of the DHHL Commission relating to a directive placed on PCDC at the DHHL Commission meeting on Tuesday, 11/16/10. During this meeting PCDC was awarded an Economic Development grant in the amount of \$250,000 and directed by the Commission to conduct community meetings notifying beneficiaries of the economic development project, its goals, objectives and outcomes.

In addition to this directive PCDC was asked to continue its conversations with the board members of Papakolea Community Association. To date, PCA and PCDC boards have not met to convene a second meeting. Mr. Asing was contacted by phone by Mr. Johnston on 12/1/10. No return call or conversation has occurred.

Notes from the Papakolea Community Development Corporation (PCDC) Board President

The PCDC Board normally leaves this newsletter update to our very capable Executive Director. Because there have been a lot of rumors and questions regarding PCDC from the communities we serve. I thought it would be appropriate for me to pass on a few comments.

Good News

First, I want to let you know that although we have had some distractions over the past couple of months. PCDC continues to focus on our mission of economic development for the benefit of our beneficiaries and their families. Here are 3 very significant events that have happened in the past 60 days:

Brand New Commercial Kitchen in 2011

It has been a 10-year dream, but persistence by our E.D. has finally paid off in the award to PCDC of a \$298,000 grant from the Kahiau Family Foundation to fully renovate and upgrade the community center's kitchen to "commercial kitchen" status. Located in the lower level of the hall, the upgrade and expansion should be completed by September 2011. There are 3 primary objectives for this kitchen that were spelled out in the comprehensive business plan developed jointly by PCDC and Kula staff:

- 1) Create economic opportunities for residents in the community.
- 2) Enable community youth to create a youth concession business and become an economic development learning experience and a community service opportunity -- we look forward to having our opi'o manage and operate a viable food concession during the afternoon and early hours of weekday evenings.
- 3) Support some of the operating costs of the community center and park.

Concerning economic opportunities, we will be looking for one or two anchor tenants from the homestead communities we serve, supporting privately owned food catering businesses. PCDC will develop a fair and transparent means to solicit, evaluate and select the anchor tenants. The kitchen will also be available to support fundraising campaigns of community-based organizations and area booster clubs, like youth football and volleyball teams.

PCDC Achieves "Level 4 - Kulia I ka Nu'u" Status

At its October 19 meeting, the Hawaiian Home Lands Commission approved the DHHL staff's recommendation to award PCDC the "Level 4" organizational capacity status. There is currently one other organization that has achieved this status. Waimanalo Hawaiian Homestead Association. Basically, this means that PCDC, as an organization, has demonstrated – through a formal process of training and assessment by DHHL and external evaluators – that it has the competency to manage economic development ventures. We are proud of that achievement, but more importantly, it allows us to develop innovative projects that can bring about job creation and business development.

Commission Approves \$250,000 Economic Development Grant

At its November 16 meeting, the Hawaiian Home Lands Commission approved an economic development grant of \$250,000. This grant is intended to officially kick off the economic development aspects of the Papakolea Regional Plan approved by the Commission in December 2009. There was some disagreement from certain individuals in the community as to the priorities of the Regional Plan. and they lobbied not to have PCDC receive this award. My primary objective, with full support of my board, was to receive this critical funding for use by the community. We are the only organization within the entire Papakolea Region qualified to receive that funding at this time and it seemed foolish to turn it away. PCDC's role is to be a resource. We will hold a number of community meetings to review the economic development planning and review priorities. Those meetings are part of the requirement of the grant and part of the funding is to do just that. We look forward to those community meetings.

Leadership Meetings

I need to acknowledge that unfortunately we have had some serious relationship issues between the PCDC and PCA boards. Most of the issues, in my opinion, are based upon misinformation. However, I have personally met the leadership of PCA and know that our objectives are the same – to serve the people of our community. PCA has brought some valid issue to my board's attention and we will address any legitimate concern. One of these is a more open process in filling board seats. PCDC will ensure the process is open and transparent to qualified members of the community.

Our two boards had a formal first meeting on November 15, with a facilitator appointed by DHHL. We look forward to continued dialogue and frankly, I don't think we need an outside facilitator. We wish the boards of the Papakolea CA. Kewalo HHCA, Kalawahine SA and Kula no na Po'e Hawaii success and look forward to full partnerships to strengthen our community's social and economic foundation for self-determination.

Finally, because there have been unfounded rumors, I just want to express to all that Puni Kekauoha, PCDC's Executive Director, has the full confidence of the PCDC board of directors and our aloha and appreciation for her dedication to the community.



Forever Thankful

It was at least a year ago that our darling "Uncle Kimo" came into our lives. Dirk Soma, Kalawahine resident gathered a meeting to discuss Hawaiians and math. This is when Uncle Kimo, Dr. James W. Miller, Ed.D was first introduced to us. He was born and raised in Hilo but spent a great portion of his life in Boston, Massachusetts receiving his doctoral degree from Harvard University in 1967. He was a short statured man who grew into this amazing giant in our presence. Within days of that meeting, Uncle Kimo had emailed to say that he wanted to work with the youth of Papakolea. He wanted to help improve math skills. He was concerned that there would be too many meetings talking about what should be done and he was ready to act. He wanted nothing in return, just to be here to help anyone who needed. He was the first person that I met whose curricula vitae (resume) required a table of contents. Uncle Kimo was an Associate Professor of



Mathematics feaching courses in College Algebra, Precalculus, Survey of Math, Basic Math, Student Preparatory Workshops: MCAT, LSAT, and GRE at Chaminade University. His special skills included teaching Algebra, Geometry, Trig/Solid Geometry, Biology, Chemistry, Physics, General Science, and Choral Music. He was a husband, father, brother, grandfather, scholar, educator, electronics engineer, choir director and had sung barbershop quartet music.

He was willing to provide SAT prep, PSAT and individual tutoring. He had been coming to the park for weeks before we learned that he had been catching the bus, rain or shine from Chaminade University to the park and then home. That is also when we found out he was then 78 years old. He also shared that he was headed home to Boston when the 9/11 tragedy occurred and he had not arranged to return since that time. We arranged for transportation from the university to the park and from the park to home, Kukui Towers for all of his sessions. He wanted to give back for the education he received. He said his benefactors were anonymous but he knew Hawaiians supported his accomplishments; therefore, he wanted to give back to the Hawaiian community.

Uncle Kimo was very concerned that the way math is being taught in the schools was leaving Hawaiians at a disadvantage because the problem may not be in finding the answer but whether the questions are understood. He had a way of making the hard seem so simple when looking at math problems. His patience was amazing. He never gave up on any of us, nor would he allow us to become defeated by a problem. I spent a lot time with Uncle Kimo, he had been guiding me on additional educational pursuits because he saw no need to stop where I am, there is further to go he would say, you're not finished, now let's look at the problem, we are not looking for answers yet. We spent months exploring the problem in preparation for what would come next. He tutored a group on SAT preparation providing all of the materials needed at his own expense. He did his tutoring in a group setting or one-to-one, making a great difference in the life of those he encountered. He was only stern with us once. We had been working on a grant proposal and midway through decided against the submission and stopped writing. He shared great concern and words of wisdom with us about never allowing anyone to get into our heads and have us believe we can't do something. "Don't let anyone get into your head and have you question your abilities and what you know and have you change your direction" he scolded "that's how they stop us, you know what I mean". He was convinced that someone had shaken our confidence and he was not having it. He was all about being confident in who you are and being able to acquire the skills to get the job done. This is what learning is about he would say, you may not know now but you will, if you are willing to be teachable. When learning of his passing, a student shared, "Uncle Kimo was generous with his time, patience and knowledge".

Our dear Uncle Kimo had been away from the park for just a short time to get some needed rest. However, on Wed. November 10 we received a phone call that he had passed away at his home on Oahu, Monday November 8. He was 79 years old. I am forever thankful for the time we had with this amazing man. Those who knew him, will miss him always, he was so easy to love.

For I know the plans I have for you," declares the LORD, "plans to prosper you and not to harm you, plans to give you hope and a future. "Jeremiah 29:11..."
