

# DISCOVERY HARBOUR RESIDENTIAL VACANT LOTS OFFERING FREQUENTLY ASKED QUESTIONS

# **<u>1. Do I need to respond to this offering?</u>**

If you are interested in this offering, you will need to fill out the Response Form and return it to the DHHL postmarked by May 3, 2021.

If you are not interested, you can complete the same form and indicate the reason you are not interested. You will be deferred from this offering and remain on the wait list based on your original application date. You will not go to the bottom of the list.

If you do not respond, it will indicate that you are not interested, and you will be deferred from this offering to remain on the wait list based on your original application date. You will not go to the bottom of the list.

# 2. What is a vacant lot offering?

A vacant lot option provides the applicant with an opportunity to build the type and size home that meets their needs and is in the price range that is conducive to their financial capability.

# 3. Is the VIRTUAL Orientation meeting on May 8, 2021 mandatory?

No, participation in the orientation meeting is not mandatory. However, this is your opportunity to learn more about this offering and to ask questions. A lot of information will be shared at the orientation meeting. If you are not able to attend the meeting, all of the information will be available on the DHHL's website at <u>http://dhhl.hawaii.gov/awards/</u> including a recording of the meeting.

# 4. Do I need a financial prequalification prior to lot selection?

No, it is not a requirement for selecting a vacant lot, however, within 7 days after selecting a lot, you will be required to contact an approved lender to start a construction loan application.

# 5. Do I need to do anything prior to selecting a lot?

Yes, you will need to attend a Vacant Lot Process meeting that will provide information about the process, timelines, kuleana, etc. If after this meeting you decide you want to proceed to the lot selection meeting, you will be required to sign a Lot Reservation Agreement. If you decide not to proceed to the lot selection meeting, you will be deferred from this offering and will remain on the waitlist based on your application date.

# 6. Do I need to be present at the Lot Selection Meeting to select a lot?

Yes, you do need to be present, however, if you are unable to attend you can have someone select a lot on your behalf with a notarized proxy. Your representative will need a hard copy of the notarized proxy and a Government or State I.D. in order to select a lot. If your representative does not have both, they will not be able to select a lot. A picture of the notarized proxy and/or ID will not be accepted.

# 7. Who is responsible for building the home on a vacant lot?

The beneficiary is responsible to manage the building process on a vacant lot. More information will be shared at the orientation and Vacant Lot Process meeting.

## 8. How soon do I need to occupy my lot?

Pursuant to Section 208 of the Hawaiian Homes Commission Act, "The lessee may be required to occupy... within one year after the commencement of the term of the lease."

## 9. Can I transfer the lease once I receive the award?

Upon receipt of a lease, you may request a lease transfer after your home is completed because a vacant lot cannot be transferred. The transfer request can be made through the DHHL East Hawaii District Operations Branch, provided all parties meet the conditions of a transfer.

## **10. Will I have to join the Discovery Harbour Association?**

Yes, as a lessee you will be required to join the Association and pay the current annual fee of \$100. Please confirm this with the Discovery Harbour Association.
