DHHL Wait List Mail Codes

R = One Return

This code flags a beneficiary's mailing address as possibly non-viable because a department mailout was returned as undeliverable. After the second consecutive return of a department mailout, the code is changed to a "K" code and the department will no longer attempt to mail information to this address.

K = Bad Address

This code indicates the department has had two consecutive mailouts returned because the address is not viable. The department will not send any further mailouts to this individual until the address is updated via a signed written request from the applicant.

I = Deferred Status

This archaic code predates the "K" mail code and was functionally, in some ways, the same as the "K" code with some key differences. In the past, where a beneficiary had a non-viable address or did not respond to repeated department requests for additional genealogical documentation, the individual was formally placed on a "deferred status" with the approval of the Hawaiian Homes Commission. As adding the code in the past required Commission approval, removing the "I" code today also requires Commission approval. Accordingly, the department requires a signed written request from the applicant to update the beneficiary's contact information before it is submitted to the Commission to remove the "I" code.

D = Deceased

This code means the department has a death certificate on file for the applicant and the decedent has a viable mailing address.

S = Deceased + One Return

This mail code is a combination of "D" and "R" codes.

L = Deceased + Bad Address

This mail code is a combination of "D" and "K" codes.
