## SUMMARY:

The Department of Hawaiian Home Lands (DHHL) posted an online survey to the Malama Cultural Park website following the third beneficiary consultation meeting on November 2, 2021. The online survey remained open until December 3, 2021, for beneficiary and community input. Survey questions involved the identification of issues, opportunities, and priorities in five (5) delineated planning zones within the park. The survey also presented and solicited feedback on four (4) alternative management strategies for the park.

A total of six (6) individuals responded to the online survey. Four (4) responses were submitted by homestead lessees. One (1) respondent indicated that they were married to a homestead lessee. One (1) respondent indicated that they were a successor to a homestead lessee. All respondents were residents of Moloka'i.

The survey questions and responses are summarized below:

## SURVEY QUESTIONS:

### ***What types of activities should occur in each of the management zones?***

#### ***Zone 1: Canoe Area***

- Canoe.
- Canoe community events.
- Let the canoe club continue as is.

#### ***Zone 2: Wetland***

- Education purposes or community projects/maintenance.
- Remove pickle weed, keawe, and other weeds and replace with native plants.

#### ***Zone 3: Malama Platform***

- Community & private events such as makeke, pa'ina, etc.
- Remove weeds replace with native grass and irrigate.
- Post an information sign/board with history, pictures, and other pertinent info.

#### ***Zone 4: Community Development Area***

- Community & private events such as makeke, pa'ina, etc.
- Multi uses such as Saturday market, community events (examples: Na Wahine & Moloka'i Hoe celebration and other community gathering).
- Remove the two buildings (jailhouse and courthouse). I know they were brought there as historically significant, but they are beyond repair and are falling apart. They are a safety hazard.

#### ***Zone 5: Hio Parking***

- Parking or drive thru for makeke.
- Remove anything not belonging there & improve parking area.

*Unspecified:*

- Start with developing environment - plants, trees according to area. The environment will dictate activities.
- Cultural based.

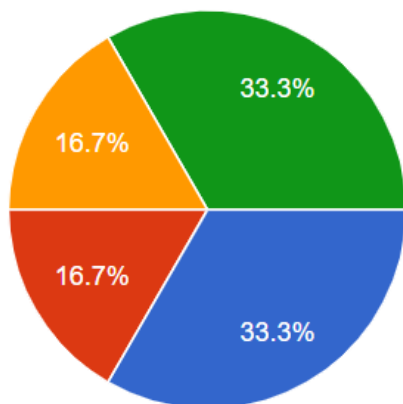
