During the first meeting, we discussed issues and opportunities, and beneficiaries shared their vision for Anahola looking ahead. In the second meeting, we addressed questions and requests for information from the first meeting and reviewed a draft vision and values statement. We also began brainstorming a list of potential projects together that can address the issues and concerns shared, while supporting the overall vision for Anahola.

We look forward to seeing you at Community Meeting #3 on March 31st and Community Meeting #4 on June 6 and continuing our work together to make this Regional Plan reflective of the community's vision and achievable for community members and beneficiary-serving organizations.
