



DUST SCREEN NOTES:

- 1. CLOTH BARRIER NOT SHOWN IN FRONT VIEW.
- 2. CLOTH BARRIER TO BE A "GEOTEXTILE" OR "NURSERY SHADE."
- 3. LUMBER SIZES ARE NOMINAL INCHES.
- 4. AS SHOWN, CLOTH TO BE BURIED AT BASE TO INDICATED DIMENSION.
- 5. 1X2 CLOTH BARRIER CAPS TO BE NAILED @ 12" O.C.
- 6. BURLAP IS NOT ACCEPTABLE AS THE CLOTH BARRIER.
- CLOTH TO HAVE NO HORIZONTAL SEAMS.
 VERTICAL SEAMS TO BE MADE OVER UPRIGHTS ONLY.
- 9. ALL SEAMS TO BE CAPPED WITH MINIMUM OF 1X2.
- 10. ALL JOINTS TO BE SECURELY FASTENED BY MECHANICAL MEANS.
- 11. TREES SHALL BE TRIMMED, AS REQUIRED, TO INSTALL DUST BARRIER.
- 12. TREE TRIMMINGS SHALL BE DISPOSED OF OFFSITE.
