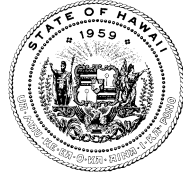

FARM PLAN REQUIREMENT


