A performance bond and payment bond equal to one hundred percent of the Total Base Offer Amount will be required if the Total Base Offer Amount exceeds fifty thousand dollars (\$50,000).

Provide the labor, materials, and equipment for the pressure testing and chlorination of portions of the existing waterlines and laterals shown on drawings for conveyance over to Department of Water Supply. The parcel is located in the Maku'u Subdivision, Department of Hawaiian Home Lands (DHHL) located on Niaulani Street, Kauhanae Place, Kapika Street, Kapika Place, and Kauakahi Place in accordance with the construction documents and technical specifications, and in compliance with all applicable laws and regulations and other related work. Any damage caused by the Contractor shall be repaired at no cost to DHHL to the satisfaction of the Project Manager. The Contractor shall be responsible to restore any damaged areas back to the original condition or better. Labor wages shall comply with the current State of Hawaii wage rate schedule.

The Contractor shall include in his quote a contingency amount of \$15,000.00 for work due to unforeseen conditions and for additional work directed by DHHL. The unspent portion of the contingency shall be deducted from the contract amount.

A pre-bid meeting and site inspection is scheduled on **Thursday**, **November 7**, **2024 at 9:00 a.m.**, **HST**, at the intersection of Niaulani Street and Kauakahi Place in Maku'u.
